It is the Board's desire to hear public comments on agenda items. As it is important to maintain order during the meeting, please adhere to the following rules of order if you wish to speak:

1. All citizens wishing to speak must first be recognized by the Chairperson.
2. The Chairperson will not call for public comments on an item until after a motion has been made and seconded and the board has had adequate opportunity to discuss the item.
3. Please stand and clearly state your name and address after being called on to speak.
4. All comments must be directed to the Chairperson.
5. **TIME LIMIT – THREE MINUTES PER PERSON PER ITEM.** (If a person needs more than three minutes, prior arrangements must be made with the District Secretary).
6. Statements should not be repetitive.

1. Call to order and roll call.
2. Approval of Minutes: **Regular Meeting: 07/21/09**
3. Call to Public.
4. District Manager's report; items to be discussed include plant and recharge statistics for July, permit compliance, progress on ASR Well No. 5, status of former State Trust Land, Flow Equalization Basin Expansion/Interim Digester Mods project and addition of fifth microfiltration rack, Saguaro Woods property, Reclaimed Water Use agreement, proposed meeting with Town Manager, and general direction from Board.
5. Controller's report; items to be discussed include status of income and expenditures, billing, report on collection efforts to date, and general direction from Board.
6. Discussion and consideration to approve Resolution No. 245 directing staff to take action to cancel the November 3, 2009 election on August 20, 2009 pursuant to A.R.S. Section 48-2010(A). (RH)
7. Discussion and consideration to approve Resolution No. 246 which ratifies the District's policy entitled "Identify Theft Prevention and Mitigation Policy". This policy provides for District compliance with Federal and state requirements. (RH)
8. Update on the District's effluent delivery study. (RH)


10. Adjournment.
