1. All citizens wishing to speak must first be recognized by the Chairperson.
2. The Chairperson will not call for public comments on an item until after a motion has been made and seconded and the Board has had adequate opportunity to discuss the item.
3. Please stand and clearly state your name and address after being called on to speak.
4. All comments must be directed to the Chairperson.
5. **TIME LIMIT – THREE MINUTES PER PERSON PER ITEM.** (If a person needs more than three minutes, prior arrangements must be made with the District Secretary).
6. Statements should not be repetitive.

1. Call to order and roll call.
2. Assumption of Chairman's duties by Vice Chairman and election of new Vice Chairman.
3. Approval of minutes: **Regular Meeting: 12/19/06**
4. Call to public.
5. Consideration to select replacement Director for seat vacated by Director Putterman.
6. Swearing in of new Directors.
7. General Manager's report; items to be discussed include plant and recharge statistics for December, permit compliance, progress on South Area Reclaimed Water Distribution System Modifications project, progress on addition of fifth microfiltration rack and ASR 5, progress on Consent Order, status of State Trust Land, Crestview Repeater Site, Pump Station No. 4 Modifications and Force Main, Flow Equalization Basin Expansion/Interim Digester Mods project, Aquifer Protection Permit (APP) amendment, tracer study, ASR Wells 3 & 4, Eagle Mountain pump station rehabilitation, and general direction from Board.
8. Controller's report; items to be discussed include status of income and expenditures, billing, report on collection efforts to date, and general direction from Board.
9. Consideration to engage A-PAC to do foundation remediation work at Pump Station No. 18. (RH)


