1. All citizens wishing to speak must first be recognized by the Chairperson.
2. The Chairperson will not call for public comments on an item until after a motion has been made and seconded and the board has had adequate opportunity to discuss the item.
3. Please stand and clearly state your name and address after being called on to speak.
4. All comments must be directed to the Chairperson.
5. **TIME LIMIT – THREE MINUTES PER PERSON PER ITEM.** (If a person needs more than three minutes, prior arrangements must be made with the District Secretary).
6. Statements should not be repetitive.

3. Call to Public.
4. District Manager's report; items to be discussed include plant and recharge statistics for April, permit compliance, progress on ASR Well No. 5 Project, Fountain Lake IGA, status of former State Trust Land, Reclaimed Water Use Agreements for Golden Eagle Park and Desert Vista Park, AWTF Chlorine Feed System Mods Project, diffuser failure in digester, AWTF Membrane System Replacement Project, Replacement of Influent Screens and Influent Pumps Project, and general direction from Board.
5. Controller's report; items to be discussed include status of income and expenditures, billing, report on collection efforts to date, and general direction from Board.
6. Discussion and consideration to approve Controller's contract for FY 2013/2014. (TM)
7. Consideration to approve Resolution No. 255, call for a non-partisan election on November 5, 2013. (RH)
8. Discussion regarding the District's current maximum sick leave accrual. (RH)

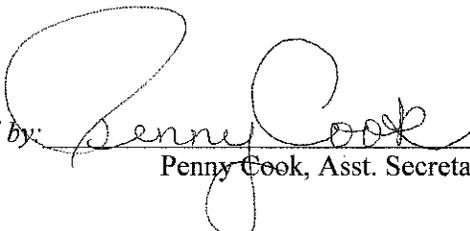
