# Agenda Item No. 1 Call to order and roll call

## Agenda Item No. 2 Call to Public

There was no public comment.

#### Agenda Item No. 3

#### Discussion regarding sodium pollution in wastewater.

Chairman Maroon would like to discuss possible solutions to try and solve the sodium pollution in wastewater and decide which ones the District would like to put efforts into this year.

After discussions, it was suggested that education be continued, and a volunteer effort and partnership effort be encouraged with the Town. Chairman Maroon suggested that a coalition be formed with two individuals from the Board and two individuals from the Town Council to discuss options for addressing sodium. Director Bell suggested that an environmental person and a business, like a golf course, be included in the coalition. Director Bell and Director Butler are willing to represent the District in the coalition.

Chairman Maroon will contact Mayor Dickey and share with her that this is what the District would like to do and would like the Town Council's participation.

Director Dudash suggested the District website have sodium pollution education and link from the Town website making the residents of Fountain Hills aware of the situation.

#### Agenda Item No. 4

<u>Discussion regarding "Gift Clause" decision by Arizona Supreme Court and its relevance to the sodium remediation credit.</u>

Legal Counsel reported on the recent Arizona Supreme Court case, Schires v. Carlet, involving Article 9, Section 7 of the Arizona Constitution, referred to as the "Gift Clause". The decision clarifies that a public entity providing an economic benefit to a private party must receive, in return, direct benefits having a

proportional fair market value. Legal Counsel suggested the decision may have implications for the District's Sodium Remediation Program. The District Manager indicated the Sodium Remediation program will be reviewed as part of the 2021-2022 fiscal year budget process.
